Course Title Change – Entry 2026

The title of DC001 Bachelor of Early Childhood Education has changed to DC001 Bachelor of Education in Early Childhood for entry 2026. There is no structure or content change to the course.

The title of DC123 BSc in Data Science will change to DC123 BSc in Data Science and Artificial Intelligence for entry 2026. There is no structure or content change to the course.

Entry Requirement Clarification for 2026

DC110 Business Studies International - The general entry and course requirements for entry 2025 have not changed.

In addition to the general entry requirements, applicants must have a minimum of O4 or H6 in Mathematics and minimum of H4 in a language other than English or Irish. Students choose a language option upon entry into the course, French or German or Spanish (Intermediate Level) or Chinese or Japanese (Beginners Level). **Students who choose French/German or Spanish must have a minimum of H4 in the language they wish to study.** Students who wish to study Chinese or Japanese will take the language at beginners level.

All applicants must meet the H4 language requirement in a language other than English or Irish.

Submission of EU Qualification Results (Outside UK & Ireland). DCU applicants presenting school examination results from within the EU, but from outside the UK/Ireland, must submit certified copies of final examination results and English translation of all documentation to the CAO. For applicants with results from previous years, this information must be uploaded to CAO within 10 days of submitting their CAO application. For those taking exams in this current year, these results must be submitted to CAO a minimum of 12 days before the relevant offer round. In the case of Round 1, this should be no later than 1st August. This is to allow adequate time for assessment and processing. Any results received after 1st August may be considered for later rounds, subject to availability of places. This is a DCU requirement.

QQI FET Routes for DCU Entry 2026

DCU now has QQI FET routes to 91% of DCU courses.

All DCU QQI FET entry requirements are published on the CAO website and can be found [here](#). Just enter the DC code and the minimum entry requirements will be displayed.

Please note that for each course, applicants must present the required award and required grades in each component award (module) as published on the CAO website.

Applicants should verify with their FET provider that the “Essential Major Award” they are taking provides any required “Essential Component Awards” (modules) required for their courses of interest. Applicants who meet this eligibility requirement may then compete for a quota of places on each course.

QQI FET minimum entry requirement changes

The QQI FET minimum requirements for DCU Nursing Programmes DC215, DC216, DC217 and DC218 have changed for entry 2026. The requirements will be as follows:

Minimum of 5 distinctions required which must include:

- D20001 or 5N0749 Anatomy and Physiology
and
- 5N4325 Nursing Theory and Practice or 5N0578 Care Support

DC208 Psychology and DC210 Psychology and Disruptive Technology – These courses will be accepting award 5M2181 Applied Social Studies for entry 2026, provided all essential components are presented to meet published requirements.
