2025 Applications: School Data

For several years, we have provided schools with information regarding the outcomes of their students' CAO applications. Following a review of this service, we have decided to continue offering the data upon request. However, the fee for this service has not been updated in some time and no longer covers the cost of provision. Therefore, the fee has been increased for 2025.

Due to technical constraints, we can supply data only for schools located in the Republic of Ireland.

For school-based candidates that completed the 2025 Leaving Certificate, we can provide a summary page showing the number of applicants from the school who were offered and who accepted places on each HEI course.

For those who require it, we can now also provide similar data for 2025 QQI FET applicants.

**Please note** we do not provide any information that could identify individual applicants, such as names, addresses, examination numbers, or CAO application numbers.

To avail of this service, **all** of the following steps must be completed:

1. Complete the order form on the reverse of this letter and return it by post to:

- 2. Make a payment of €68.00 by bank transfer to the account details listed on the order form.
- 3. **Include the School Roll Number** as the payment reference. Without this, CAO will be unable to identify the source of the payment.

Data will not be issued unless all steps are completed.

Once the process is correctly followed, the School Data will be issued by email to the address provided on the order form.

**Please note** requests must be received no later than **16th January 2026**. We will be unable to provide data after this date.

Requests can only be made for 2025 data.

In supplying this information, the Central Applications Office requires that schools do not use the data in any way that could result in the creation of "league tables."
